Discussion regarding Chicken BBQ that Mohawk Club will sponsor for 2010-11 season with all athletes participating and funds going to general needs. Will consider late October 2010 date

Concession discussion was linked to New Business item for coordination with Music Boosters.

New Business:

Discussion held with Music Booster representative regarding the consolidation of concessions stands for football season. Music Booster profit for Fall 2009 was approximately \$600. Mohawk Club offered to have a profit sharing/volunteer sharing and operate only one concession stand. There would be the possibility of offering additional food items and selling items in the stands. There was pop left over from the track season that Pepsi did not come and pick up. Mohawk Club has already paid bill and Greg will attempt to get a credit and then donate to the Parish Festival as it will expire before any other events occur.

200+ Club report from Bo Faeth. Drawings will be held this year during Boys and Girls basketball games. This will give people more time to join 200+ Club and support the athletic programs.

Fr. Wiebl joined the meeting to discuss the overall SW athletic budget. There is a large deficit and Fr. Wiebl is looking for any ways that the Mohawk Club and help alleviate part of the deficit. Discussion held on status of CDs and whether a donation could be made. Decision tabled so members could have time to think over.
